Colorado currently has 34 NAWCA projects either completed or underway. These projects have conserved a total of 328,560 acres of wildlife habitat. NAWCA funding of more than \$17 million stimulated partner contributions of over \$71.5 million. These figures do not include multi-state projects.

PLATTE RIVER WETLANDS PARTNERSHIP IV

This is the fourth phase of the Platte River Wetlands Partnership, which conserves wetlands and other habitats important to nonbreeding migratory bird populations in the South Platte River Basin of northeastern Colorado. Activities will permanently protect 1,800 acres, restore and manage an additional 1,129 acres and enhance 374.7 acres to improve the functional quality of wetlands on private lands in the basin.

The project pays special attention to improving habitats on tracts accessible to the public found along the river. The Platte River ecosystem - including shallow water wetlands, warm water sloughs and sandy, braided river channels in proximity to productive agricultural land - provides critical roosting and foraging sites for millions of ducks, geese and other waterbirds on their seasonal migrations mallards, northern pintails, a waterfowl species of concern. Many other waterbirds benefit from these conservation activities. Management activities performed to benefit waterfowl also benefit sandhill cranes, many types of shorebirds and other wildlife species.
